Landlord agrees to make available to Exhibitor, exhibition space in accordance with this contract for the Clinton County Fair to be held on the following date: July 18-24, 2021 (Sunday -Saturday) at the Clinton County Fairgrounds, 1899 Methodist St., Carlyle, IL. Exhibition building will be open to the public at minimum 5:30pm – 9:00pm.
2. Please identify the type of your exhibit. \_\_\_\_\_
3. Exhibitor agrees to pay the sum of \$100.00 for a 10'x10' space, for the entire week. Individual days are available for \$30.00 per night. Please circle which nights you will be there, below. Check in during the day and must take down exhibit at close of evening unless staying consecutive nights.
4. Exhibitors shall register with the fair officials at the fair office before setting up. Booth spaces will be assigned on a FIRST COME basis when contracts are receive accompanied with full payment.
5. Exhibitors must furnish their own table(s), chair(s), fan(s), extension cord(s), etc. **NO** helium balloons are permitted due to ceiling fan destruction.
6. No food vendors permitted inside the building.
7. Exhibitor shall comply with regulations established by the Landlord from time to time for the orderly management and presentation of the fair.
8. The lease expires at the end of the term specified in item 1 above and no notice of termination shall be necessary.
9. This lease may be terminated by Exhibitor at any time more than thirty (30) days before the fair with full refund. Termination less than thirty (30) days before the fair will cause forfeiture of all rent paid.
10. Exhibitor shall maintain at its expense all insurance it deems necessary for vandalism, theft, fire, storm, or other casualty, liability to the public, etc. Landlord assumes no responsibility for loss to the contents of any exhibit or for liability to the public. Exhibitor agrees to defend and indemnify Landlord for any liability arising out of activities of Exhibitor.
11. This agreement is effective when signed by Exhibitor and a duly authorized representative of Landlord.
